### **Police Department Report**

Detective Beekman reported service calls. Unable to obtain data at this time, 45 summons and/or tickets, 24 reports, 6 arrests, and Patrol Hours 145. There has been an increase in attempts at stealing and tampering with vehicles in the 1200 / 1300 block of Weleda. Officers are increasing hot spot patrols in the area and following up on leads. Officers conducted a saturation patrol on July 4<sup>th</sup>. As a result, officers received credible information of illegal sales of fireworks from a vehicle in the City of Cool Valley. The officers on the detail located the vehicle and confiscated approximately \$5,000.00 in illegal fireworks, which were being sold, and summonses were issued.
